Thesis Gold is an exploration company focused the prolific Golden Horseshoe of British Columbia where the Company is defining and developing the substantial resource potential of its Ranch and Lawyers projects.

Thesis Gold, following its strategic merger with Benchmark Metals, is unlocking the combined potential of the Ranch and Lawyers Gold-Silver Projects in the Toodoggone mining district of north-central British Columbia, Canada. The 2022 Preliminary Economic Assessment for the Lawyers project alone projected an open-pit mining operation that would yield 163,000 gold equivalent ounces annually over a 12-year span.

Over our more than 20-year history, including 15 years as a publicly-listed entity on the Australian Securities Exchange, we have developed a reputation for excellence in project delivery, safe operation, and targeted investment in the local economy and community.

We are proudly local, and around 75% of our 2,500-strong workforce lives in the local communities around our mine sites. We believe in helping communities grow, ensuring benefits flowing from our operations are seen and felt locally.
